NOTICE TO COMPLAINANT

This deposition will be used by the Magistrate to determine whether or not there is probable cause to issue a criminal complaint against the person accused of a crime in this complaint.

The complaint and deposition you are filing must be sworn to by you. FALSE STATEMENTS IN THE COMPLAINT OR DEPOSITION MADE BY YOU COULD POSSIBLY RESULT IN CIVIL OR CRIMINAL LIABILITY FOR YOU IF THE PERSON YOU ARE CHARGING IS FOUND NOT GUILTY. Once a complaint is signed, the legal process it initiates is very difficult to stop. You are not a party to the case but rather the case is between the City of Jasper and the defendant. It violates the constitution of this state and is a criminal offense to initiate a criminal prosecution solely for the purpose of collecting a civil debt. The person you are filing this complainant against will have a permanent criminal record no matter how the case is decided.

It is the responsibility of the complainant to notify this court if you change your address. You must appear in court and testify to the facts alleged in this complainant and deposition. IF YOU FAIL TO APPEAR AFTER BEING SUBPOENAED TO COURT, THE COURT WILL ISSUE A WARRANT FOR YOUR ARREST FOR CONTEMPT OF COURT. The court could also assess a fine and court cost against you.
