- 2) The City Council of the City of Jasper, Alabama, designates the <u>City Clerk</u> as the officer to whom public records requests shall be submitted;
- 3) The City of Jasper, Alabama, shall respond to any request received pursuant to this policy in accordance with the provisions of the Public Records Law of the State of Alabama, § § 36-12-40 through -46, Code of Alabama (1975);
- 4) These procedures shall be made generally and reasonably available to the public, and posted in a conspicuous place within Jasper City Hall.

ORDINANCE NO.: 2024 – 15

AN ORDINANCE TO ADOPT SELECTED REVISED VERSIONS OF THE INTERNATIONAL BUILDING CODE AND RELATED BUILDING CODES FOR USE WITHIN THE CITY OF JASPER, ALABAMA

WHEREAS, the City Council of the City of Jasper, Alabama, has, from time to time, adopted various iterations of the International Building Code and its associated electrical, plumbing, and other codes, for governance of buildings within the city limits of the City of Jasper, Alabama; and

WHEREAS, the City Council of the City of Jasper, Alabama, has conducted, after proper notice, a public hearing as provided for by §11-45-8, <u>Code of Alabama</u> (1975), relative to the proposed adoption of the instant Ordinance adopting by reference the International Building Code and related building codes; and

WHEREAS, there was no opposition to the adoption of such Codes presented to the City Council of the City of Jasper, Alabama; and

WHEREAS, the City of Jasper Building Department recommended the adoption of the said Codes;

BE IT THEREFORE ORDAINED, as follows:

Section 1. Adoption of Codes.

The following Building Codes are hereby adopted by the City Council of the City of Jasper, Alabama:

- a). 2024 International Building Code;
- b). 2024 International Energy Conservation Code;
- c). 2024 International Residential Code;
- d). 2024 International Plumbing Code;
- e). 2024 International Mechanical Code;
- f). 2024 International Fuel Gas Code;
- g). 2024 International Existing Building Code; and
- h). 2024 National Electrical Code.

Section 2. Effective Date.

This Ordinance shall become effective immediately after its passage and publication as required by the laws of the State of Alabama.
